

REGULAR MEETING OF THE
MAYOR AND TOWN COUNCIL OF THE TOWN OF WILSONVILLE,
ALABAMA HELD ON AUGUST 1, 1955

A regular meeting of the Mayor and Town Council of the Town of Wilsonville, was held in the Town Hall, the regular place for holding meetings of said Council on August 1, 1955, at 7:30 o'clock p.m. and there were present at said meeting, the Mayor S. S. McEwen, and the following Councilmen: G. K. Baker, D. F. Bolton, V. J. Fulmer, and G. W. Rayfield.

Councilman G. W. Rayfield introduced the following Ordinance:

CONFIRMATORY IMPROVEMENT ORDINANCE NO. 3

WHEREAS, in and by an Ordinance entitled "Improvement Ordinance No. 2," duly ordained by the Mayor and Town Council of the Town of Wilsonville, Alabama, at a meeting duly held on June 6, 1955, at 7:30 o'clock p.m., the construction of certain paving within the corporate limits of the Town of Wilsonville, Alabama, was determined upon, ordered, authorized and ordained; and

WHEREAS, copies of said Improvement Ordinance No. 2 were sent by registered mail and the postage prepaid, to the persons last assessing for town taxation the property to be assessed for such improvements at their last known address, more than ten days before the meeting of the Mayor and Town Council on June 27, 1955, as therein provided for, said copy having been so mailed on June 10, 1955, and

WHEREAS, said Improvement Ordinance No. 2 of June 6, 1955, was duly published once a week for two consecutive weeks in the Shelby County Reporter-Democrat, a newspaper published in the town of Columbiana, Alabama, which newspaper has a general circulation in the town of Wilsonville, Alabama, said publications appearing in the issues of said paper of June 9, 1955, and June 16, 1955; and

WHEREAS, in and by the terms of said Ordinance and notices thereof it was ordered and provided that the Mayor and Town Council of the town of Wilsonville, Alabama meet at 7:30 o'clock p.m. in the Wilsonville School auditorium in Wilsonville, Alabama, on the 27th day of June, 1955, for the purpose of hearing and that as such time, it would hear any protests, objections or remonstrances that may be made to said improvements, the manner of making the same or the character of material or materials to be used; and

WHEREAS, on the 27th day of June, 1955, at 7:30 o'clock p.m., the Mayor and Town Council met at said Wilsonville School, the same having been the date, time and place so fixed by said Ordinance and the notices thereof for the holding of such meeting and to hear any such objections, protests or remonstrances that may be made and it being determined that all of the persons affected by said public improvements had not had access to the plans and specifications for making of said improvement and it was determined by said Mayor and Town Council that said meeting adjourn to the 25th day of July, 1955, at 7:30 o'clock p.m. to be held in the Wilsonville School for the purpose of hearing any such objections, protests or remonstrances that may be made to the making of said improvements, the manner of making the same or the character of material or materials to be used and notice having been given of said adjourned meeting both by announcing it at said open meeting on June 27th, 1955, and also by giving notice by publication as required by law in the Shelby County Reporter-Democrat; and

WHEREAS, on the 25th day of July, 1955, at 7:30 o'clock p.m. the Mayor and Town Council met at the Wilsonville School, the same having been the date, time and place so fixed by said notices of adjourned meeting for the holding of such meeting to hear any such objections, protests or remonstrances that may be made, and those being present being called upon to protest, object or remonstrate in person, by attorney or by petition against such improvements, the materials to be used or the manner of making the same should they so desire, and said persons having been informed that the Council would consider any and all such

objections, protests or remonstrances; and

WHEREAS, no objection or protests or remonstrances having been made to the making of said improvements, the manner of making the same or the character of material or materials to be used, except for the following:

Southern Railway Company protested the paving on McGowan Road
Mrs. C. H. Stewart, Jr. and Mr. James A. Snoddy protested the paving on Hebb Road

Said parties own property adjoining the streets named, but their ownership along said streets are less than a majority in frontage of the property adjoining said streets and affected by said paving; and

WHEREAS, the Mayor and Town Council did not act upon said Improvement Ordinance at said meeting on July 25, 1955, but adjourned said meeting to the 1st day of August, 1955, at 7:30 o'clock p.m. for the purpose of confirming, amending, modifying or rescinding said Ordinance. The Mayor and Town Council determined that McGowan Road from its intersection with the easterly line of Alabama Highway 25 and extending in a northeasterly direction 1825.0 feet to point of ending and that Hebb Road beginning at a point approximately 40 feet southeast of the Southern Railroad Grade Crossing in Wilsonville and extending southeasterly a distance of 1472 feet to the point of ending shall be constructed as provided for in said Improvement Ordinance No. 2. The Mayor and Town Council determined that Jackson Street shall not be improved as set out in said Improvement Ordinance No. 2.

NOW THEREFORE, BE IT ORDAINED BY THE MAYOR AND TOWN COUNCIL OF THE TOWN OF WILSONVILLE, ALABAMA AS FOLLOWS:

SECTION ONE. That the Mayor and Town Council find and determine that the matters and things hereinabove set out in this Ordinance are true and correct and have been done as set out herein.

SECTION TWO. That the said original Ordinance entitled "Improvement Ordinance No. 2" of June 6, 1955, heretofore ordained by the Mayor and Town Council of the town of Wilsonville, Alabama, at a meeting thereof regularly held on June 6, 1955, be and the same hereby is readopted and in all things ratified and confirmed, and the said improvements ordered to be made as therein specified, except as follows:

(a) That Section 1 of Improvement Ordinance No. 2 be amended by striking therefrom the first paragraph having to do with McGowan Road and inserting in lieu thereof the following:

That McGowan Road from its intersection with the easterly line of Alabama Highway 25 and extending in a northeasterly direction 1825.0 feet to point of ending, said point being the east line of the Stinson Hill property, shall be constructed 18 feet wide to include the necessary grading and excavation, the construction of a 6 inch soil aggregate base course and shall be paved with a double bituminous surface treatment.

(b) That Section 1 of Improvement Ordinance No. 2 be amended by striking therefrom the sixth paragraph thereof having to do with Jackson Street.

(c) That Section 1 of Improvement Ordinance No. 2 be amended by striking therefrom the ninth paragraph having to do with Hebb Road and inserting in lieu thereof the following:

That Hebb Road beginning at a point approximately 40 feet southeast of the Southern Railroad Grade Crossing in Wilsonville, and extending southeasterly a distance of 1472 feet to the point of ending, shall be constructed 16 feet wide to include the necessary grading and excavation, the construction of a 4 inch soil aggregate base course and shall be paved with a double bituminous surface treatment.

After amending said Improvement Ordinance No. 2 as set out above, the same is hereby readopted and in all things ratified and confirmed and said improvements ordained to be made as therein specified, as amended.

SECTION THREE. That this Ordinance is hereby termed and designated, shall be known and may

be cited as "Confirmatory Improvement Ordinance No. 3 of August 1, 1955."

SECTION FOUR. That notice be given by the Mayor asking for bids for the work to be done under and by virtue of said Improvement Ordinance No. 2 and said Confirmatory Improvement Ordinance No. 3; said notice to describe in a general way the character and approximate quantities of such work and the types of materials to be employed, and said notice to be published once a week for two consecutive weeks in the Shelby County Reporter-Democrat, a newspaper published in Columbiana, Shelby County, Alabama, having a general circulation in the town of Wilsonville, Alabama, and the the date for receiving bids as set out in said notice shall not be earlier than two weeks after the first publication of said notice.

Said Ordinance was read at length and thereupon Councilman D. F. Bolton moved that unanimous consent of the Mayor and Council be given for the immediate consideration of, and action upon said Ordinance, which motion was seconded by V. J. Fulmer. Said motion for unanimous consent was submitted to a vote of the Mayor and Council and said vote resulted as follows:

Thereupon the Mayor in open council declared said motion carried and unanimous consent given for the immediate consideration of and action upon said Ordinance.

Councilman G. K. Baker moved that said Ordinance be adopted, which motion was seconded by Councilman G. W. Rayfield. Said motion for the adoption of said Ordinance was submitted to a vote of the Mayor and Council and said vote resulted as follows:

A regular meeting of the Mayor and Town Council of the Town of Wilsonville, Alabama, was held in the Town Hall in Wilsonville, Alabama, the regular place for holding meetings of said Council on the 30 day of July, 1956, at 7:30 o'clock p.m. and there were present at said meeting, S. S. McEwen, Mayor, and the following Councilmen: V. J. Fulmer, G. W. Rayfield, and D. F. Bolton.

Councilman G. W. Rayfield introduced the following Ordinance:

ORDINANCE NO. 7A

BE IT ORDAINED BY THE MAYOR AND TOWN COUNCIL OF THE TOWN OF WILSONVILLE, ALABAMA, AS FOLLOWS:

SECTION ONE: That the regular municipal election in the town of Wilsonville, Alabama, shall be held on the third Monday in September, 1956, for the purpose of electing a Mayor and five members of the Town Council, who shall assume the duties of their respective offices on the first Monday in October following such election and shall serve without compensation for a term of four years.

SECTION TWO: That the voting place of said election shall be City Hall in the Town of Wilsonville, Alabama.

SECTION THREE: That the Mayor and Clerk be and they are hereby directed to give notice of said election at least forty days prior to the date of holding the same by posting notice in three public places in the Town of Wilsonville, Alabama, as provided by law.

SECTION FOUR: That any person desiring to become a candidate at such election may become such a candidate by filing in the office of the Mayor a statement of candidacy accompanied by affidavit taken or certified by any officer authorized to take acknowledgements in this State; that such person is duly qualified to hold the office for which he desires to become a candidate. Such statement shall be filed at least thirty days before the date set for holding such election and shall be substantially in the following form:
