SECTION FOUR. That notice be given by the Mayor asking for bids for the work to be done under and by virtue of said Improvement Ordinance No. 2 and said Confirmatory Improvement Ordinance No. 3; said notice to describe in a general way the character and approximate quantities of such work and the types of materials to be employed, and said notice to be published once a week for two consecutive weeks in the Shelby County Reporter-Democrat, a newspaper published in Columbiana, Shelby County, Alabama, having a general circulation in the town of Wilsonville, Alabama, and the date for receiving bids as set out in said notice shall not be earlier than two weeks after the first publication of said notice.

Said Ordinance was read at length and thereupon Councilman D. F. Bolton moved that unanimous consent of the Mayor and Council be given for the immediate consideration of, and action upon said Ordinance, which motion was seconded by V. J. Fulmer. REGULAR MEETING OF THE  
MAYOR AND TOWN COUNCIL OF THE TOWN OF WILSONVILLE,  
ALABAMA, HELD ON 30 DAY OF JULY, 1956.

A regular meeting of the Mayor and Town Council of the Town of Wilsonville, Alabama, was held in the Town Hall in Wilsonville, Alabama, the regular place for holding meetings of said Council on the 30 day of July, 1956, at 7:30 o'clock p.m. and there were present at said meeting, S. S. McEwen, Mayor, and the following Councilmen: V. J. Fulmer, G. W. Rayfield, and D. F. Bolton.

Councilman G. W. Rayfield introduced the following Ordinance:

ORDINANCE NO. 7A

BE IT ORDAINED BY THE MAYOR AND TOWN COUNCIL OF THE TOWN OF WILSONVILLE, ALABAMA, AS FOLLOWS:

SECTION ONE: That the regular municipal election in the town of Wilsonville, Alabama, shall be held on the third Monday in September, 1956, for the purpose of electing a Mayor and five members of the Town Council, who shall assume the duties of their respective offices on the first Monday in October following such election and shall serve without compensation for a term of four years.

SECTION TWO: That the voting place of said election shall be City Hall in the Town of Wilsonville, Alabama.

SECTION THREE: That the Mayor and Clerk be and they are hereby directed to give notice of said election at least forty days prior to the date of holding the same by posting notice in three public places in the Town of Wilsonville, Alabama, as provided by law.

SECTION FOUR: That any person desiring to become a candidate at such election may become such a candidate by filing in the office of the Mayor a statement of candidacy accompanied by affidavit taken or certified by any officer authorized to take acknowledgements in this State; that such person is duly qualified to hold the office for which he desires to become a candidate. Such statement shall be filed at least thirty days before the date set for holding such election and shall be substantially in the following form:

I, the undersigned, being first duly sworn, depose and say that I am a citizen of the Town of Wilsonville, Alabama, in said County and reside at \_\_\_\_\_ in said Town; that I desire to become a candidate for the office of \_\_\_\_\_ in said Town for the term of 4 years at the election of such office to be held on the 17th day of September, 1956, that I am duly qualified to hold said office if elected thereto and I hereby request that my name be printed upon the official ballot at said election.

SECTION FIVE: That the Mayor shall and he is hereby directed to notify the Inspectors, Clerks and Returning Officer of their appointment and he is further directed to post a list of them in three public places in the town of Wilsonville, Alabama.

SECTION SIX: That the polls shall be opened between the hours of eight or nine o'clock in the morning and kept open without any intermission or adjournment until the hour of six o'clock in the afternoon, and no longer.

SECTION SEVEN: Be it further ordained that this Ordinance be published by posting copies in three public places within the limits of the Town of Wilsonville, Alabama, one of which places shall be at the Post Office or the Mayor's Office of such Town.

SECTION EIGHT: This Ordinance shall be entitled and shall be cited as, "AN ORDINANCE TO CALL A REGULAR MUNICIPAL ELECTION TO BE HELD IN THE TOWN OF WILSONVILLE, ALABAMA, ON MONDAY, SEPTEMBER 17, 1956, FOR THE PURPOSE OF ELECTING A MAYOR AND TOWN COUNCILMEN FOR SAID TOWN."
