

SECTION FOUR. That the detailed estimates of the cost of such improvements on file in the office of the Town Clerk aggregate \$6450.00 and that the Town Council of Wilsonville will meet on the 2nd day of October, 1961, in the Town Hall in Wilsonville, Alabama, at 7:00 o'clock p.m. to hear any objection or remonstrances or protests that may be made against said improvements, the manner of making the same or the character of materials to be used.

SECTION FIVE. That this ordinance be published for two successive weeks in a newspaper published in the Town of Columbiana, Alabama, and that the Town Clerk be and is hereby directed to have the same so published; and that the Town Clerk also be and is hereby directed to send a copy of this ordinance by registered mail, postage prepaid, to the persons last assessing for Town taxation the property which may be assessed for said improvements, at their last known addresses, said notices to be mailed not less than ten (10) days before the meeting of the Town Council provided for in the next preceding section hereof.

Said ordinance was read at length, and thereupon Councilman S. S. McEwen moved that unanimous consent of the Mayor and Council be given for the immediate consideration of, and action upon said ordinance, which motion was seconded by Councilman Lee Reinhardt. Said motion for unanimous consent was submitted to a vote of the Mayor and Council and said vote resulted as follows:

Councilman Winston Baker introduced the following Ordinance:

CONFIRMATORY IMPROVEMENT ORDINANCE NO. 7

WHEREAS, in and by an ordinance entitled "Improvement Ordinance No. 6" duly adopted by the Town Council of the Town of Wilsonville, Alabama, at a special meeting thereof held on September 6, 1961, the paving of certain streets in said town were determined upon, ordered and authorized;

WHEREAS, said Improvement Ordinance No. 6 was duly published once a week for two consecutive weeks in the Shelby County Reporter, a newspaper published in the City of Columbiana, Alabama, and having a general circulation in the town of Wilsonville, Alabama, said publications appearing in the issues of said paper of September , 1961, and September , 1961;

WHEREAS, in and by said ordinance and the notices thereof, it was ordered and provided that the Council of the Town of Wilsonville, Alabama, meet at 7:00 o'clock p.m. on the 2nd day of October, 1961, for the purpose of hearing, and that at such time it would hear any objections or remonstrances that may be made to said improvements, the manner of making the same or the character of material or

materials to be used;

WHEREAS, on the 2nd day of October, 1961, at said meeting as aforesaid, held at the Town Hall in the town of Wilsonville, Alabama, the regular place for holding said Council meetings at 7:00 o'clock p.m., there was a discussion of said Ordinance and a call for any objections or protests;

And, Whereas, there being no objections or protests to the making of said improvements and to the manner of making the same or the character of material or materials to be used;

NOW, THEREFORE, BE IT ORDAINED BY THE TOWN COUNCIL OF THE TOWN OF WILSONVILLE, ALABAMA, AS FOLLOWS:

SECTION ONE. That the said original ordinance entitled "Improvement Ordinance No. 6" heretofore adopted by the Town Council of the Town of Wilsonville, Alabama, at a meeting thereof held on September 6, 1961, be and the same hereby is readopted and in all things ratified and confirmed and the said improvements ordered to be made as therein specified.

SECTION TWO. That this Ordinance is hereby termed and designated and shall be known and may be cited as "Confirmatory Improvement Ordinance Number 6."

SECTION THREE. The Town of Wilsonville, Alabama, having a population of less than 2,000 inhabitants as shown by the last federal census, the Town Council elects to give notice of the passage of this Ordinance by posting notices at three public places within the corporate limits of said Town, one of which shall be posted in front of the Mayor's Office or at the United States Post Office.

Said Ordinance was read at length and thereupon Councilman Lee Reinhardt moved that unanimous consent of the Mayor and Council be given for the immediate consideration of and action upon said Ordinance, which motion was seconded by Councilman B. E. Cunningham. Said motion for unanimous consent was submitted to a vote and said vote resulted as follows:

ORDINANCE NO. 18A

BE IT ORDAINED BY THE TOWN COUNCIL OF THE TOWN OF WILSONVILLE, ALABAMA, AS FOLLOWS:

SECTION ONE:

(a) That it shall be unlawful for any person, firm or corporation to drive any motor vehicle in excess of 40 miles per hour from the City Limits of the town of Wilsonville, Alabama, on Highway 25 going in a westerly direction to its intersection with McGowan Road.
