

The Wilsonville Town Council met for the regular meeting, Monday, April 05, 2010, in the Council Chamber of the Wilsonville Town Hall. Mayor Pro Tem, Terry Newman called the meeting to order at 6:30 P. M.

The opening prayer was given by Melissa Rosetta.

The following council members answered roll call: Calvin Gill, Patricia Johnson, Lee McCarty, Terry Newman, Alan Revis, Melissa Rosetta. Dennis Blackerby was not present.

The minutes of the March 01, 2010, regular council meeting, which had been mailed to the council members before the meeting, were reviewed. Calvin Gill made a motion to accept the minutes, as presented; Alan Revis seconded. The motion passed with the following vote: Calvin Gill, yes; Patricia Johnson, yes; Lee McCarty, yes; Terry Newman, abstain; Alan Revis, yes; Melissa Rosetta, yes.

The minutes of the March 22, 2010, special council meeting (mailed to the council members prior to the meeting) were reviewed. Melissa Rosetta made a motion to accept the minutes, as presented. Calvin Gill seconded the motion which passed with the following vote: Calvin Gill, yes; Patricia Johnson, yes; Lee McCarty, yes; Terry Newman, abstain; Alan Revis, yes; Melissa Rosetta, yes.

The financial reports for March, 2010, mailed to the council members earlier, were reviewed. Melissa Rosetta made a motion to accept the financial reports, as presented. Alan Revis seconded, and the motion passed with the following vote: Calvin Gill, yes; Patricia Johnson, yes; Lee McCarty, no; Terry Newman, yes; Alan Revis, yes; Melissa Rosetta, yes.

Karen Morris addressed the council concerning the art class she is teaching on Monday and Wednesday mornings. She displayed some of the art the class has done. She stated interest has been shown in having an evening class and perhaps, a class for children.

Clem Muck and Pauline Williams, representatives of the Church of Jesus Christ of Latter-day Saints, addressed the council concerning researching genealogy. The church recently did family histories for the mayors of Wilsonville, Columbiana, Chelsea, Calera, and Montevallo. The church has sixteen consultants who can work with anyone interested in researching their genealogy. Their office is open Tuesday, Thursday, and Saturday from 10:00 A. M. until 2:00 P. M. or by appointment. The church has extensive information which is being converted from microfilm to PDF format, and there are web sites, such as familysearch.org, which are available. Mrs. Williams presented a power point presentation. A packet of information was presented to each council member.

Annexation Ordinance 100405 was presented. The annexation petition was approved at the March 01, 2010, meeting.

ORDINANCE NO. 100405

WHEREAS, on or about the 1st day of March, 2010, William S. Robinson and Antoinette Robinson filed a petition with the Town Clerk of the Town of Wilsonville, Alabama, as required by Sections 11-42-20 and 11-42-21, Code of Alabama, 1975, as amended, petitioning and requesting that the property hereinafter described be annexed to the municipality of the Town of Wilsonville, Alabama, which petition contained an accurate description of the property proposed to be annexed together with a map of the said property showing its relationship to the corporate limits of the Town of Wilsonville, Alabama, and the signature of the owners of the property described were signed thereto;

NOW THEREFORE, BE IT ORDAINED BY THE TOWN COUNCIL OF THE TOWN OF WILSONVILLE, ALABAMA, AS FOLLOWS:

1. That the Town of Wilsonville, Alabama, does adopt this Ordinance assenting to the annexation of the property owned by the above referenced property owners, as described in:

EXHIBIT "A"

to the municipality of the Town of Wilsonville, Alabama.

2. That the corporate limits of the Town of Wilsonville, Alabama, be extended and rearranged so as to embrace and include such property, and such property shall become a part of the corporate area of such municipality upon the date of publication or posting of this Ordinance, as provided for in the Code of Alabama, as cited above.
3. That the Town Clerk be and she is hereby authorized and directed to file a copy of this Ordinance, including an accurate description of the property being annexed, together with a map of the said property showing its relationship to the corporate limits of the Town of Wilsonville, Alabama, to which said property is being annexed in the office of the Judge of Probate of Shelby County, Alabama.
4. That the Zoning Map of the Town of Wilsonville, Alabama, and any other official maps or surveys of the Town shall be extended to reflect the annexation of the above described property, and that a copy of this Ordinance be transmitted to the Town Planning Commission and the Zoning Administrator.

The clerk requested the cemetery fund budget be amended to reflect the \$30,507.50 capital expenditure for the wrought iron arches which was approved at the March 01, 2010, meeting. Patricia Johnson made a motion to amend the cemetery fund budget adding \$30,507.50 to capital expenditures. Melissa Rosetta seconded. The motion passed with the following vote: Calvin Gill, yes; Patricia Johnson, yes; Lee McCarty, yes; Terry Newman, yes; Alan Revis, yes; Melissa Rosetta, yes.

The clerk also requested the general fund budget be amended to reflect the \$9,403.10 capital expenditure for the rescue tool for the fire department. Alan Revis made a motion to amend the general fund budget adding \$9,403.10 to fire department capital expenditures. Calvin Gill seconded the motion which passed with the following vote: Calvin Gill, yes; Patricia Johnson, yes; Lee McCarty, yes; Terry Newman, yes; Alan Revis, yes; Melissa Rosetta, yes.

The clerk read a resignation letter from Faye Hylton, who is resigning from the Cemetery Committee, effective immediately. Lee McCarty made a motion to accept the resignation; Melissa Rosetta seconded. The motion passed with the following vote: Calvin Gill, yes; Patricia Johnson, yes; Lee McCarty, yes; Terry Newman, yes; Alan Revis, yes; Melissa Rosetta, yes.

Mr. Newman distributed information concerning the Shelby County Bike Loop Project. Part of the loop will involve Highway 61 in Wilsonville. The county is requesting each town or city involved to designate five parking spaces for the bikers to park their cars while using the Bike Loop. The Town will receive a large bike rack and the county will line off the parking lot. There was discussion. Everyone felt this

will be a good thing for the Town. More information will be presented at the May council meeting.

Melissa Rosetta spoke about the June 27th Celebration which will include dedication of a historic marker and the arches at the cemetery and a marker at Town Hall for The Year of Alabama Small Towns and Downtowns, as well as the annual God and Country Celebration. Mayor Liveoak would like to have refreshments inside the Town Hall following the two dedications. Mrs. Rosetta will get prices from DJ's Barbeque and Coyote Grill N More for the food at God and Country. Prices for these items will be presented at the May council meeting.

Rebekah Kendrick addressed the council about speeders on McGowan Road. The speeding takes place mainly when Yellowleaf Park is in use for either practices or games. She is concerned for the safety of small children who live on McGowan. The deputy has patrolled the area. As long as he is there, the traffic slows, but as soon as he leaves, it becomes a problem again. Speed limit signs and children playing signs have been placed on the street. Mrs. Kendrick would like to have speed bumps installed. Mr. Newman read a letter to Mrs. Liveoak from the Shelby County engineer stating Shelby County does not install speed breaks or stop signs to control speed. There seems to be a dispute about whether McGowan Road is a county road or a city street. Mr. Newman stated he will look into getting strips of some kind.

Public Comment.

There was no public comment.

There being no further business to come before the council, Alan Revis made a motion to adjourn the meeting. Melissa Rosetta seconded, and the motion passed with the following vote: Calvin Gill, yes; Patricia Johnson, yes; Lee McCarty, yes; Terry Newman, yes; Alan Revis, yes; Melissa Rosetta, yes.
