

The Wilsonville Town Council met Monday, December 06, 2010, in the Council Chamber at the Wilsonville Town Hall. Mayor Rosemary Liveoak called the meeting to order at 6:31 P. M.

The meeting was opened with prayer by Councilwoman Melissa Rosetta.

The minutes of the November 01, 2010, regular meeting, mailed to council members prior to the meeting, were reviewed. Melissa Rosetta made a motion to accept the minutes as presented. Mayor Liveoak reported we did not receive the grant for the sewer improvement project. She passed out copies of the revised draft concerning the sewer system to go to the Alabama Department of Environmental Management. She requested council members bring their materials about the sewer project, probably from the February, 2010, meeting material, to the January meeting. Harry Chandler, SouthWest Water, will be at the meeting to discuss beginning the repair work.

The mayor reminded everyone of the safety meeting, Tuesday, December 14, 2010, 6:30 P. M., at Bernie's on Main, Columbiana. The guest speaker will be Chad Scroggins.

Lee McCarty asked about the recycling bin. It seems to be missing from its usual location. The mayor explained the bin was gone for a few days while Mr. Bell was working on the corner lot. It is now back on the edge of the lot.
